## **Important Notes:**

- <u>Behavioral Cards</u>: Students may be issued Yellow, Orange, or Red Cards based on the recommendations of the Disciplinary Committee and at the discretion of the school management. The type of card issued will depend on the severity, frequency, and impact of the behaviour.
- External Counselling: If external or professional counselling/therapy is recommended by the school for a student's well-being or behavioral improvement, it is the responsibility of the parents to arrange and ensure regular follow-up.
- Exceptional Cases: In extreme or critical situations, these hoolreserves the right to directly enforce Level 3 consequences, bypassing Level 1 or Level 2, depending on the nature and seriousness of the offense.
